#### The Hottest Late-Stage Companies

We are pleased to share the Q2 2021 edition of The Setter 30 – our ranking of the most highly sought-after pre-IPO companies in the global secondary market. The Setter 30 is based on a survey of over 500 leading global investors in late-stage companies, as well as proactive interest that we have received from secondary buyers in the last several months.

While the deals on this list are the most frequently targeted by investors, they may not necessarily be the most easily found. For example, Discord, Epic Games, and Databricks have many potential buyers, but there is rarely if ever any supply of these shares on the market.

Our team and respondents noted a number of current trends reflected in the survey results. First, the continued supremacy of SpaceX and Stripe atop the survey as companies that are widely perceived to be transformative of their entire industry. Fintech continues to be the hottest sector overall with Klarna, Plaid, Robinhood and Carta all claiming positions in the top ten. Enterprise collaboration tools (Airtable, Gitlab, Figma), data analytics (Databricks, Rubrik, ThoughtSpot) were also areas deemed attractive by our respondents.

Companies planning to go public have continued to be very popular. Among these on the current list are Robinhood, SentinelOne and Toast. Marqeta also placed high in the survey, but was ultimately excluded as it went public just prior to the publication of this report.
