The Most Sought-After Venture Backed Companies in the Secondary Market Q3 2021

The Hottest Late-Stage Companies

We are pleased to share the Q3 2021 edition of The Setter 30 – our ranking of the most highly sought-after pre-IPO companies in the global secondary market. The Setter 30 is based on a survey of over 500 leading global investors in late-stage companies.

While the deals on this list are those most frequently targeted by investors, they are often not those most easily found. For example, Discord, Canva, and Databricks have many potential buyers, but there is rarely if ever any supply of these shares on the market.

Our team and respondents noted a number of current trends reflected in the survey results. First, SpaceX and Stripe remained dominant atop the survey for the 3rd quarter in a row, as they are widely believed to be industry transformative firms with limited competitors (SpaceX was in a league of its own with more than double the votes of #2 Stripe!). Fintech continues to be white hot with Klarna, Plaid, Carta and Kraken all landing in the top ten. Enterprise collaboration tools (Airtable, Gitlab, Discord, Figma), challenger banks (Chime, Revolut and Nubank) and data analytics (Databricks, Rubrik) continued to be areas that are highly sought after in the market.

As always, companies with imminent potential public offerings (e.g. Reddit, Nubank, and Gitlab) are in high demand due to the potential uplift to valuation and imminent liquidity. Toast originally made the rankings, but it went public prior to the survey's release. Meanwhile the longer-term trend of companies remaining private for longer also continued in spite of the recent inexorable rise of public markets, with the vast majority of the Setter 30 consisting of \$10bn+ valuation companies.
